No person may handle live ammunition before making an application for membership. A minimum of six months must elapse between the date of application and acceptance as a full member (unless the applicant is a member of an approved gun club). Attendance during this time must be regular. Probationary members must, if in possession of firearms or ammunition, be supervised by the Range Officer or a full member of the club who holds a Firearm Certificate. Applicants must complete the visitor's book at every attendance until a full member. Every applicant must be sponsored by a full member of this club.

Declaration under Section 21 of the Firearms Act 1968

If you would like to join Ross on wye target shooting Club, you must complete this form in addition to the Membership Application Form.

It is an offence for a person who is prohibited under Section 21 of the Firearms Act 1968 to have a firearm or ammunition in their possession at any time. This Section applies to any person who has been sentenced to imprisonment or to youth custody or detention in any young offender's institution for three months or more. It also applies to a person who has been sentenced to imprisonment of three months or more where the sentence is suspended. A person sentenced to a period of imprisonment of 3 months or more but less than 3 years is prohibited for 5 years from the date of release. A person sentenced to 3 years imprisonment or more is prohibited for life. A person sentenced to 3 months imprisonment or more where the sentence is suspended is prohibited for a period of five years beginning with the second day after which the sentence is passed. It is an offence for a person to transfer, let, hire, or lend a firearm or ammunition to someone whom he knows or has reasonable grounds for believing to be a prohibited person.

Declaration:
